Developments in Asphalt Binder/Emulsion Specifications and Asphalt Institute's Role

Learn about proposed changes to asphalt binder and emulsion tests and specifications and how the Asphalt Institute can have a role in helping AASHTO COMP understand and properly implement them. Research has the potential to significantly impact the testing and specification of paving grade asphalt binders. There are proposed changes to the intermediate temperature parameter in AASHTO M 320 and M 332, the addition of ΔT_c as a specification parameter, the addition of a qualifying specification parameter (ΔT_f) to use in instances when ΔT_c fails to meet specified minimum requirements and changes to the procedures for short- and long-term conditioning of asphalt binders.
